Subject: Selection of eligible candidates for the posts of Junior Resident in Govt. Medical College Baramulla advertised vide notification no. 04 of 2023 dated 06-03-2023.

**OFFICE ORDER No. 26 -RA of 2023**

**Dated: 20-04-2023**

Whereas, Govt. Medical College Baramulla, vide advertisement No.04 of 2023 dated 06-03-2023, advertised the posts of junior residents, seeking applications from the eligible candidates on academic arrangement basis under SO-364 OF 2020 dated 27-11-2020.

Whereas, in terms of the method of recruitment in vogue for the posts of Jr. Residents, 60% weight-age is earmarked to the academic merit, and the viva/ written Test shall carry 40% weightage. Subsequently, the written Test for these posts was conducted by the institute on 5<sup>th</sup> of April 2023.

Whereas, based on the performance of the candidates in the written test (OMR Based) and the Academic score, the institute vide Notification No. GMC/BLA/2023/4844-45 dated 11-04-2023, published the result/score sheet of the candidates.

Whereas, the Result List notified for these posts inter-alia provided that the candidates may represent through the email address [principalmedicalcollegebla@gmail.com](mailto:principalmedicalcollegebla@gmail.com) within two days from the date of its Notification with any grievance. The representations so received from the candidates were examined and those based on merit, were taken into consideration and necessary changes, where-ever required, were made while finalizing the selection. Further, the institute, vide notice no. GMC/BLA/2023/4872-75 notified the list of candidates falling under consideration zone, who were subsequently called for indication of preferences and Document Verification.

Whereas while scrutinizing the documents and preference of candidates during counselling/document verification, nominal discrepancies found were rectified. Furthermore, the candidates who failed to appear before the Document Verification Committee, have not been considered for selection for these posts.

*Now therefore, the Final selection List of the candidates for the posts of Junior Resident in various departments of Govt. Medical College Baramulla along with the waiting list is hereby notified as per the details forming 'Annexure-A' to this Notification. However, the candidates are provisionally selected on academic*

*arrangement basis initially for a period of 06 months which can be extendable on the basis of performance and good conduct report by the concerned head of the department/section.*

However, engagement of the selected doctor shall be subject to the following conditions;

1. That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 10 days from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
  - He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
  - He/she will not indulge in private practice during the tenure. In case he is found, doing private practice his appointment shall be terminated without any notice.
  - He/she shall not leave the department before the completion of his/her sanctioned tenure.
  - He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
  - He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
4. Salary will be disbursed only after the proper CID Verification of the candidates.
5. No experience certificate will be issued if he/she leaves without completing his/her sanctioned tenure.
