

However, engagement of the selected doctor shall be subject to the following conditions.

1. That the doctor shall submit his joining report in the office of Principal GMC Baramulla within 15 days from the date of issuance of this selection order.
2. That he shall submit an affidavit duly attested by first class magistrate to the effect that:
 - a. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - b. He/she will not indulge in private practice during the tenure. In case he is found, doing private practice his appointment shall be terminated without any notice.
 - c. He/she is a non- PSC candidate and in case of PSC candidate he/she shall submit NOC from the competent authority.
 - d. He/she shall not leave the department before the completion of his/her sanctioned tenure.
 - e. He/she will complete his/her sanctioned tenure and will provide 01-month prior notice before resignation from the post.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
4. Salary will be disbursed only after the proper CID Verification of the candidate.
