2. **That their engagement/appointment shall be subject to the submission of CID Verification certificate and the said junior resident doctors shall apply for CID verification through online mode from the Administrative Office of GMC Baramulla immediately after the publication of this notice.**
3. First month's salary of the candidate/s shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of tenure/s at the time of relieving.
4. The Junior Resident posts are transferrable in nature and interdepartmental transfers can be initiated by the institution (as and whenever deemed necessary) to ensure the efficient Patient care/Academics of the institution and the Selected/Engaged residents shall have no claim of staying in the initially allocated Department.
5. The selected candidates shall register themselves on HPR Portal of National Health Authority (under Ministry of Health and Family Welfare) and MedLeaPR Portal. They
