- 2. That the doctors shall produce all the relevant documents (as sought by the institution at the time of advertisement) in original along with the 01 Xerox set in the office of Registrar Academics GMC Baramulla at the time of joining this institution.
- 3. The selected/appointed candidate/s shall submit the Additional Qualification Registration Certificate (issued by the JK-Medical Council) within a period of 2 months from the publication of this notification.
- 4. Engagement of PSC-Confirmed / In-service candidates (if any) shall be subject to the submission of NOC and Relieving from the parent Department at the time of joining this institution.
