1. That the **doctor/s shall submit joining report** in the office of Principal GMC Baramulla within a period of 21 days from the date of issuance of Appointment/Engagement order.
2. That the doctors shall produce all the relevant documents (as sought by the institution at the time of advertisement) in original along with the 01 Xerox set in the office of Registrar Academics GMC Baramulla at the time of joining this institution.
3. The selected/appointed candidate/s shall submit the Additional Qualification Registration Certificate (issued by the JK-Medical Council) within a period of 2 months from the publication of this notification.
4. Engagement of PSC-Confirmed / In-service candidates (if any) shall be subject to the submission of NOC and Relieving from the parent Department at the time of joining this institution.
5. That the **selectees shall submit affidavit** duly attested by 1st class judicial magistrate at the time of joining (format attached under Annexure A)

8. No Experience Certificate shall be issued in favour of the resident doctor who resign mid-way without completion of the sanctioned tenure in this institution.
