- That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 03 days from the date of issuance of this selection order.
- 2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - a. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - b. He/she will not indulge in private practice during the tenure. In case he is found, doing private practice his appointment shall be terminated without any notice.
 - c. He/she shall not leave the department before the completion of his/her sanctioned tenure.
