GENERAL TERMS AND CONDITIONS TO THE TENDERERS:

1. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids.
2. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed.
3. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents.
4. Contractor should strictly adhere to the instructions/orders from the Competent Authority. The transfer of contract or sub-contract is not permissible.
5. The Prices quoted shall remain valid for 180 days from the date of opening of the Bid and in respect of accepted bid the prices quoted shall remain **valid till the work process is over.**
6. Rates quoted shall be deemed to be inclusive of cost of manpower, travelling, lodging, food expenses, software/hardware, Stationery, prints and presentation material. No escalation of whatsoever nature shall be payable in future due to any revision/amendment in any act/statute governing this contract. No extra remuneration/reimbursement will be admissible.
7. The technical bids of bidders, qualifying the bidder eligibility criteria shall be considered for further evaluation.
8. Tender containing false, misleading information will be rejected and may also be liable for consequences for submitting false information.
9. The execution of work process may be completed within 30 days from award date.
10. Payment will be made after the satisfactory execution of each work mentioned in the Financial Bid. Payment will be made through E-payment mode. No advance payment shall be made in any circumstances.
11. Tenders with any condition including that of conditional rebates in the tender document shall be rejected forthwith.
12. **The bidders will have to do an inspection of the area and the rates that they will quote should include all things like labour, material, etc.**

Detailed Instructions to the Tenderers:

1. SCOPE OF CONTRACT:

The bids are invited for supply, installation, testing and commissioning of electrical sign boards detailed in schedule of requirement in "Annexure A" needed for Government Medical College, Baramulla.

2. Bid document cost and EMD

The cost of tender document shall be furnished in the shape of Demand Draft in favor of **Chief Accounts Officer GMC Baramulla**. The bidder has to furnish scanned copy of the demand draft on line before the due date of submission of technical bid. However, original instrument of bid documents cost and EMD in a sealed envelope clearly super scribed as bid for Maintenance, Operation of X-Ray Services in Associated Hospital, GMC Baramulla with bid reference No. and the name of the bidder must reach the tender inviting Authority by post / courier on or before the opening of technical bid, failing which the bid shall be rejected.

Firms which are registered as MSME units shall be considered for exception of EMD as well as cost of tender document but the bidder has to submit a performance security deposit of the same amount.

3. **Forfeiture of bid security**

The bid security will be forfeited in the following cases:-

- a) When bidder withdraws or modifies the offer after opening of tender and before acceptance of tender
- b) When bidder does not execute the agreement, if any, prescribed within the specified time or extended time by competent authority on the request of the bidder
- c) When bidder does not deposit the security money after the supply order is given.
- d) When he fails to submit samples of quoted items on demand within the prescribed time.
- e) When bidder violates any terms and conditions of the tender documents.

4. **Period of validity of bid.**

- a) The bid must remain valid for minimum of 180 days from the date of opening of technical bid. A bid valid for a shorter period shall be rejected by the tender inviting authority as nonresponsive.
- b) The bidder cannot withdraw his bid within bid validity period and also after execution of rate contract agreement or issuance of supply order for any of the agreed items.

5. **Duration of contract**

The tender will be over once all the supplying, installation and testing is complete and after obtaining the installation certificate from the Officer In charge.

However if at any point of time during the contract it was found that the supplier is not servicing as per the norms laid down in tender document/Rate Contract/work order, the competent authority reserves every right to cancel the contract.

6. **Signing of Contract**

Promptly after notification of award, within ten days from the date of the letter of intent, the successful bidder shall execute the contract (as per agreement **Annexure B**) on Rs.100/- stamp paper purchased in the name of the successful bidder, duly signed and dated, to the Tender Inviting Authority by registered / speed post or in person.

7. **Submission of bids and Eligibility Criteria:**

The bids are to be submitted online in two parts in the e -tender portal(www.jktenders.gov.in).Each process in the e- procurement is time stamped and the system can detect time of login of each user including the bidder.

a) **Part 1-**

The technical bid shall be submitted on the tendering portal with all the required documents as mentioned in tender document. **However, a copy of the same shall reach the office of the tender inviting authority before the date of opening of technical bid, failing which tenders are liable to be rejected.**

- v) Registration of firm with the concerned department of Govt. of J&K.

- vii) Experience of atleast 01 year in the relevant field.
- viii) Latest income tax returns.
- ix) **Non- Blacklisting Declaration:** An affidavit on Rs.50/- stamp paper duly attested by **1st Class Judicial Magistrate.**

b) Part 2 –

Price bid format (BoQ) is not enclosed in the bid document. It has to be downloaded from the e - procurement portal (jktenders.gov.in). The price bid format (excel sheet available in e-Tender portal) is specific to a bid and is not interchangeable. The price bid format file (BoQ itemwise-FormBased) shall be downloaded from the e-Tender portal and the bidders shall fill up only following fields in the sheet BoQ1:

Column 7 Rates in Rs./paisa per unit of the item mentioned in that row

Column 9 Tax Amount in Rs./ Paisa per unit of the item mentioned in that row

Quantities shown in the Price Bid are only indicative. The actual quantity shall be worked out later on as per requirement.

8. Signing of the BID

The bidder shall digitally sign on all statements, document, certificates uploaded on his own responsibility for the correctness / authenticity. If any of the information furnished by the bidder is found to be false/fabricated/bogus, the EMD /bid security shall stand forfeited and his /her name shall be recommended for blocking of portal registration and the bidder is liable to the blacklisted.

9. Price BID Opening

The opening of the price bid shall be done online by the tender inviting authority or his authorized representative. Only the price BIDs of the firms qualified in the detailed scrutiny and evaluation of the technical bid and samples verification, if any, conducted by the technical committee / Tender inviting Authority shall be opened in the second round.

10. Award of contract

The contract will be awarded to the lowest evaluated responsive bidder. In case of L1 rates being quoted by more than one bidder, the bidder having more experience will be given the award of contract.

11. Performance Security

The successful bidder shall have to submit a performance security deposit of Rs. 50,000/- within two (02) days of issuing of the work order, which will be released once the work is successfully completed.

12. Payments

PAYMENT:- 100% Payment shall be released through WDC Bill/Bank Draft within 30 days after receipt/verification of materials in the stores to the following extent.

- ✓ In case the payment is delayed due to some unavoidable reasons beyond control of the department the successful tenderer has to deliver the supply in any case

13. Penalties:

In the event of the firm failing, declining, neglecting or delaying the supply or in the event of any damage occurring or being caused by the supplier, the Government shall without prejudice to any other remedy available to it under the law for the time being in force J&K UT:

- ✓ Terminate the supply order after 30 day notice and/or
- ✓ Recover the amount of loss caused by damage, failure or default including the Consequential damages.
- ✓ Impose a penalty up to 10% of the total value of the order and confiscate earnest money.

For delay in completing of the work beyond stipulated time, Institute may impose the penalties as per following.

- First extension up to 03days or part there of @3%of the total work order amount.
- Second extension up to 07days @5%of the total work order amount.
- In case of default the Institute will have to procure the ordered items from the open market/another party at the firm's risk and expenses under Risk Purchase clause.
- Forfeit the Security Deposit/Earnest Money and/or
- Recover the amount of the loss caused by the damage, failure or default (including the consequential damages)as may be determined by the Institute.

14. Jurisdiction of Courts

All disputes arising out of this bid will be subject to the jurisdiction of courts of law at Baramulla only.
