In pursuance to the Advertisement Notice No. 05 of 2023 Dated 16-03-2023, applications were invited through online mode for the post of Scientist B (Medical) and Scientist B (Non Medical) in VRDL (Virus Research and Diagnostic Lab) at GMC Baramulla on temporary basis.

In the above backdrop, sanction is hereby accorded for the temporary engagement of the above said candidates for the posts of Scientist B (Medical) and Scientist B (Non Medical) VRDL (Virus Research and Diagnostic Lab), GMC Baramulla on contractual basis initially for a period of 1 year and further extendable based on work and conduct reported by the Principal Investigator.

The Candidates shall join within 21 days from the date of issuance of this order and the Salary of the candidate shall be fixed on consolidated basis at (Rs 56000/- + applicable HRA) per month.

The appointment is subject to the following terms and conditions:


1. The candidate must be a permanent resident of U.T of Jammu and Kashmir.
2. Canvassing in anyway will lead to disqualification of the concerned candidate.
3. All the posts will be on a contract basis for a period of one year initially extendable on the basis of satisfactory work and conduct reported by the Principal Investigator.
4. The selected candidates shall have to submit an undertaking in the shape of affidavit duly attested by the 1st class magistrate to the effect that:-
 - I. The candidate should be a permanent resident of J&K,
 - II. I will adhere to the roster of duties to be issued by the Administration.
 - III. If the documents filed by me are found wrong/incorrect at any point of time my appointment shall be cancelled.

- IV. I will not participate in any kind of strike/ Protest against the Administration during my tenure in the college
- V. He/ she has not appointed in any govt./ Semi Govt. Department and is not working there at present
- VI. Govt. Medical College, Baramulla deserves the right to terminate from the job at any time, if the performance of the selectee is not upto the expectation level as and if reported by the Principal Investigator. If the candidate wants to resign a notice period of 30 days is must.
- VII. The posts are on contractual basis and temporary; do not confer any right for the selected candidates to the permanent absorption in the department.
- VIII. NOC from the concerned District Industries Centre (DIC) and District Employment and Counseling Center to the effect that no loan under self-employment scheme has been taken by the appointee concerned
