**Subject: Temporary engagement for the post of Staff Nurse (ATF) and Counsellor (ATF) under Advertisement No: 11/GMCB of 2023, Dated 12-09-2023 in GMC Baramulla.**

In pursuance to the Advertisement Notice No. 11/GMCB of 2023 Dated 12-09-2023, 01 post of Staff Nurse (ATF) and 01 Post of Counsellor (ATF) were advertised by this Institution.

Whereas as written based examination was conducted by the I/C Controller Examination GMC Baramulla for the post of Staff Nurse (ATF) and Counsellor (ATF) on 16-11-2023 and 28-11-2023 respectively. Subsequently a selection list of above said posts was issued by I/C Controller Examination GMC Baramulla vide their selection list No. GMC/BLA/Exam/2023/412-17, dated 20-12-2023 in which the below mentioned candidates were selected for the posts mentioned against each.

6. Other relevant Documents.

*The appointment is subject to the following terms and conditions.*

1. The candidate must be a Domicile of U.T of Jammu and Kashmir.
2. Canvassing in anyway will lead to disqualification of the concerned candidate.
3. The selected candidates shall have to submit an undertaking in the shape of affidavit duly attested by the 1<sup>st</sup> class magistrate to the effect that:-


i. The candidate should be a Domicile of J&K.

- ii. I will adhere to the roster of duties to be issued by the Administration.
  - iii. I will not participate in any kind of strike/ Protest against the Administration during my tenure in the college
  - v. He/ she has not appointed in any govt./ Semi Govt. Department and is not working there at present
  - vi. Govt. Medical College, Baramulla reserves the right to terminate from the job at any time, if the performance of the selectee is not upto the expectation level as and if reported by the Concerned HOD. If the candidate wants to resign a notice period of 30 days is must.
  - Vii. The posts are on contractual basis and temporary; do not confer any right for the selected candidates to the permanent absorption in the department.
4. In-service candidates are not eligible to apply.
5. Unmarried certificate in case of female candidates belonging to reserved category.
6. That if the candidate has taken loan for self-employment from District Industries Centre (DIC)/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the Financial Advisor & CAO, GMC Baramulla for his/her salary. Financial Advisor & CAO, GMC Baramulla shall obtain an affidavit from the concerned engagee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK (GAD) of 2023, dated 06.02.2023.
7. The decision of the selection committee regarding appointment of candidate will be final and no representation will be entertained in this regard.
8. Selection committee reserves all right to change the selection procedure, rules & cancellation of rules
9. In case of adverse report about his/her character and antecedents is received from the inspector General of Police (CID) J&K the candidate shall have no right to claim his/her appointment and his/her appointment as such shall be deemed to have been cancelled ab-intio.
10. Salary of selected candidates shall not be drawn and disbursed to them unless the satisfactory CID verification report and genuineness of other Documents are received by this office in their favour.
