Whereas, applications were invited for the post of Junior Resident at Govt. Medical College Baramulla against the Walk-In interview notice No. GMC/BLA/Acad/5738-42 dated 27-12-2023 for filling up of the vacant posts of junior residents in various departments of GMC Baramulla and accordingly selection list along with waiting list for the said post was notified, vide order No: - GMC/BLA/Acad/5935-40 dated 03-01-2024.

Whereas, waiting list was operationalized vide order No. GMC/BLA/ Acad/6130-35 dated 13-01-2024 due to non-joining/resignation of junior residents in the departments of OBG/Radio-diagnosis/Physiology and Orthopedics, Govt. Medical College Baramulla.

However, engagement of the selected doctors shall be subject to the following conditions.

- That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 05 days from the date of issuance of this selection order.
- 2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - a. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - b. He/she shall not leave the department before the completion of his/her sanctioned tenure.
 - c. He/she will complete his/her sanctioned tenure and will provide 01-month prior notice before resignation from the post.
- 3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.

4. Salary will be disbursed only after the proper CID Verification of the candidates.

5. The selected candidates shall register themselves on HPR Portal of National Health Authority (under Ministry of Health and Family Welfare) and submit the hardcopy of the same as proof in the office of Registrar Academics GMC Baramulla.
