E-tender for supply of CT films to GMC Baramulla and its Associated Hospital ---

Detailed instructions to the tenderers:

1. Scope of contract

The bids are invited for supply of items detailed in schedule of requirement in "Annexure A" needed for Government Medical College and Associated Hospital, Baramulla.

a. The CT films should be compatible to below mentioned printer.

Name of Printer: Fujifilm Dry Pix Plus

Model: TSX-032A

Size of the film: 14* 17 inches (35*43 centimeters)

The items supplied should be of the exact specification and should be compatible with the above mentioned printer.

2. Eligibility criteria

Bidder shall be either a manufacturer/ importer or an authorized representative/stockiest/distributor of the manufacturer, with an average turnover of 50 lakh each for last three financial years. Only those authorized representatives/ stockiest/distributor shall be permitted to participate in the e-bid who have a letter of authorization from original manufacturer/ importer.

In case of manufacturer, it shall have a valid drug manufacturing/ drug license by the state / Central licensing authority. The proof of turnover is to be furnished in format T1 certified by the charted accountant and supported by audited annual statement.

3. Bid document cost and EMD

The cost of tender document shall be furnished in the shape of Demand Draft in favour of Chief Accounts Officer GMC Baramulla.

The bidder has to furnish scanned copy of the demand draft online before the due date of submission of technical bid. However, original instrument of bid documents cost and EMD in a sealed envelope clearly super scribed as bid for Supply of CT Scan films with bid reference No. and the name of the bidder must reach the tender inviting Authority by post / courier on or before the opening of technical bid, failing which the bid shall be rejected.

Firms which are registered as MSME units shall be considered for exception of EMD as well as cost of tender document.

3. Forfeiture of bid security

The bid security will be forfeited in the following cases:-

- a) When bidder withdraws or modifies the offer after opening of tender and before acceptance of tender
- b) When bidder does not execute the agreement, if any, prescribed within the specified time or extended time by competent authority on the request of the bidder. When bidder does not deposit the security money after the supply order is given.

- c) When he fails to submit samples of quoted items on demand within the prescribed time.
- d) When bidder violates any terms and conditions of the tender documents.

4. Period of validity of bid.

- a) The bid must remain valid for minimum of 180 days from the date of opening of technical bid. A bid valid for a shorter period shall be rejected by the tender inviting authority as nonresponsive.
- b) The bidder cannot withdraw his bid within bid validity period and also after execution of rate contract agreement or issuance of supply order for any of the agreed items.

5. Duration of contract

Once the rate of contract is finalized the rate contract shall be valid for a period of **one year** from the date of awarding of contract. However, in case of emergency, the same can be extended for three months with the approval of College Purchase Committee, GMC Baramulla.

6. Submission of bids

The bids are to be submitted online in two parts in the e-tender portal (www.jktenders.gov.in). Each process in the e- procurement is time stamped and the system can detect time of login of each user including the bidder.

a) Part 1-

The technical bid shall be submitted on the tendering portal with all the required documents as mentioned in tender document. However, a copy of the same shall reach the office of the tender inviting authority before the date of opening of technical bid, failing which tenders are liable to be rejected.

- xi) Earnest money involved in the quantities of the quoted items in the shape of CDR/FDR pledged to Chief Accounts Officer GMC Baramulla.

b) Part 2 -

Price bid format (BoQ) is not enclosed in the bid document. It has to be downloaded from the e-procurement portal (jktenders.gov.in). The price bid format (excel sheet available in e-Tender portal) is specific to a bid and isnot interchangeable. The price bid format file (BoQ itemwise –Form Based) shall be downloaded from the e-Tender portal and the bidders shall fill up only following fields in the sheet BoQ1:

Column 7 Rates in Rs./paisa per unit

Column 9 Tax Amount in Rs./ Paisa per unit

Quantities shown in the Price Bid are only indicative. The actual quantity shall be worked out later on as per requirement.

7. Signing of the BID

The bidder shall digitally sign on all statements, document, certificates uploaded on his own responsibility for the correctness / authenticity. If any of the information furnished by the bidder is found to be false/fabricated/bogus, the EMD /bid security shall stand forfeited and his /her name shall be recommended for blocking of portal registration and the bidder is liable to the blacklisted.

8. Samples to be submitted

The tenders are bound to supply only genuine items of make/model/ specification etc tender by him/ it. The purchase committee can call samples of any item from the technically qualified bidder at any time. Failure to submit the samples before the stipulated dates will lead to automatic rejection of the tender. In case the samples are not found "standard" by the technical committee, same cannot be approved for supply despite having lowest rate.

9. Price BID Opening

The opening of the price bid shall be done online by the tender inviting authority or his authorized representative. Only the price BIDs of the firms qualified in the detailed scrutiny and evaluation of the technical bid and samples verification, if any, conducted by the technical committee / Tender inviting Authority shall be opened in the second round.

10. Award of contract

The contract will be awarded to the lowest evaluated responsive bidder. In case of L1 rates being quoted by more than one bidder the quantity to be supplied shall be equally divided amongst them.

In case L1 bidder fails to execute the contract, it will be re tendered.

11. Performance security

The EMD of successful bidders shall be retained as performance security and shall be returned only after successful completion of the contract. In case, the bidder is an MSME, performance security deposit same as the value of EMD will be kept by the institution in form of performance security.

12. Shelf life of items supplied

All items supplied, the expiry date i.e. the date up to which the items shall retain its efficacy and potency shall be for a period of at least two years from the date of its manufacture and at the time of supply, should have minimum 5/6th shelf life from the date of manufacture when supplied. It is imperative that the materials supplied are in proper packaging capable of protecting the drug throughout their shelf life.

Materials supplied without following the above conditions will be rejected.

13. Payments

No advances payments towards cost of items will be made to the bidder.

Payment shall be made after receipt of quality test report from government approved test laboratories and found as of "STANDARD QUALITIES" and bills shall be cleared after receipt of funds from the Govt. The bidder must undertake that the continuity of the supplies to the Govt. Medical College Baramulla shall be maintained even in case there is delay in the payments by GMC Baramulla and as\ due to delay in release of funds by the Union Territory of Jammu and Kashmir.

14. Rate-Revision:

Successful bidders shall not be entitled for any rate—revision of price for any reason except Govt levies which become applicable after finalization of rates along with adequate documentary proof thereof.

15. Penalties:

In the event of the agency failing, declining, neglecting or delaying the supply of the materials or in the event of any damage occurring or being caused by the agency or in theevent of default or failure by the agency or if the goods supplied do not conform the order the ordered specifications or sample the institute shall without prejudice to any other remedy available to it under law for the time being in force in J&K State take recourse to all or any of the following penal action against defaulted agency:

- Make risk purchase from alternative source or from open market at the risk and cost of defaulted agency, out of the amount of Security Deposit/Earnest Money deposited by the agency/balance payment.
- For delay in supply of items beyond stipulated delivery period of supply order, *I*nstitute may accept the supplies after imposing penalty as per following.
- First extension up to 03days or part there of @3% of the delayed supply.
- Second extension up to 07days @5% of the delayed supply.
- In case of delay beyond a week supply shall be arranged from alternative sources.



- In case of default the Institute will have to procure the ordered items from the open market/another party at the firm's risk and expenses under Risk Purchase clause.
- Forfeit the Security Deposit/Earnest Money and/or
- Recover the amount of the loss caused by the damage, failure or default t(including the consequential damages) as may be determined by the Institute.

16. Jurisdiction of Courts

All disputes arising out of this bid will be subject to the jurisdiction of courts of law at Baramulla only.
