In pursuance of the recommendations made by the duly constituted Selection Committee, and in terms of the provisions contained in the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement Basis) Rules, 2020, notified vide S.O. 364 dated 27.11.2020, sanction is hereby accorded to the engagement of the following below candidates against the posts of Assistant Professor in the disciplines as indicated against each, in **Government Medical College, Baramulla**, on Academic Arrangement Basis with immediate effect:

The candidates shall report to the Principal, **Government Medical College, Baramulla**, within a period of twenty-one (21) days from the date of issuance of this order, failing which they shall forego their right to engagement, and the same shall be deemed to have been cancelled ab-initio without any further Notice.

The engagement of the candidates against the faculty posts shall be subject to the following conditions:

1. The arrangements shall be purely on temporary basis and shall not confer upon the candidates any special claim/right for their appointment against the said posts on regular basis as and when the same are filled through the JK PSC under rules.
2. The candidates shall have to execute an agreement with the Government on the prescribed form in terms of S.O 364 of 2020 dated 27.11.2020.
3. The engagement shall be for a period of one year or till the posts are filled-up on regular establishment basis on the recommendations of Jammu and Kashmir Public Service Commission, whichever is earlier.
4. The above engagements shall be regulated under other terms and conditions as specified in S.O-364 dated 27.11.2020.
5. The engagements so made on academic arrangement basis shall be extendable upto maximum of six years (one year at a time and subject to good performance and conduct) or till selections/promotions are made in accordance with the rules of recruitment governing the posts, whichever is earlier and the extension so granted under these rules shall not be beyond a period of six years under any circumstances.
6. The salary in favour of the engaged faculty shall not be drawn and disbursed unless a satisfactory report is received from the Criminal Investigation Department, J&K.


