Whereas, Govt. Medical College Baramulla, vide advertisement No.05 of 2023 dated 16-03-2023, advertised the various posts under the project entitled "Medical College Level Virus Research and Diagnostic Laboratory (VRDL)", seeking applications from eligible candidates.

Whereas, in terms of the method of recruitment in vogue for the post of **Laboratory Technician**, 10 marks are earmarked to the experience, and the written test shall carry 90 marks. Subsequently, the written Test for the said post was conducted by the institute on the 08th of June 2023.

Whereas based on the performance of the candidates in the written test (OMR Based), the institute, vide Notification No. GMC/BLA/Exam/2023/104-07 dated 28-06-2023 published the result/score sheet of the candidates. Wherein, it was further notified that candidates desirous of making representations with regard to the marks obtained in the screening test and academics may do so on the shared email id.

Further, the institute, vide notice no. GMC/BLA/Exam/2023/110-13 dated 03-07-2023 notified the list of candidates falling under the consideration zone, who were subsequently called for Document Verification.

The candidates presented their necessary documents for verification, and thorough scrutiny was carried out to ensure authenticity. However, during the verification process, discrepancies were found in the experience certificates of many candidates. Also, some of the candidates did not appear before the document verification committee.
