7. The age of the applicant at the time of filling of application form must not be below 18 years and above 45 years.
8. Canvassing in anyway will lead to disqualification of the concerned candidate.
9. All the posts will be on a contract basis for a period of one year initially extendable on the basis of satisfactory work and conduct reported by the Nodal Officer, ATF Scheme, GMC Baramulla.
