- b) State Subject/Domicile Certificate*
- c) 10<sup>th</sup> Class marks sheet/Degree Certificate*
- d) 12<sup>th</sup> Class marks sheet/Degree Certificate*
- e) Degree/Diploma in concerned field including marks Certificate (All semesters or aggregate)*

*5. One Xerox set of above certificates shall also be furnished at the time of submission of documents.*

*An affidavit duly signed by 1<sup>st</sup> class Magistrate to the effect that:-*

- 1. I will adhere to the roster of duties to be issued by the administration of GMC Baramulla.*
- 2. I will not participate in any kind of strike/protest the administration during my tenure in the college / hospital.*
- 3. My appointment will get terminated automatically and I shall have no claim on the post as soon as the appointment time is over as mentioned in the advertisement or post is filled by the competent authority on permanent basis.*



4. If the documents filed by me are found wrong / incorrect at any point of time, my appointment shall be terminated immediately and disciplinary action and legal proceedings shall be initiated against me.

**The Appointment of the candidate is subject to the following conditions:**

- a) The appointee shall report to the Principal Govt Medical College Baramulla within a period of **07 days** from the date of publication of the list, failing which he/she shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- b) The appointee shall give an undertaking in the shape of a duly signed by 1<sup>st</sup> class judicial Magistrate to the effect that:-
- He/ She has not been appointed in any other Govt or Semi Govt department and is working there at present
  - In case adverse report about his/her character and antecedent is received from the inspector general of police (CID) J&K the candidate have no right claim his appointment as such, shall be deemed to have been cancelled ab-initio.
- c) Salary of the appointee shall not be drawn and disbursed to them unless satisfactory report in respect of (b) above is received.
