Now, therefore, in view of above position, the candidate of waiting list operated above is directed to join physically in Government Medical College, Baramulla within a period of 21 days after issuance of this order. **"The engagement shall be initially for a period of six months or till the selection/promotion/further continuation is made in accordance with the recruitment rules, governing the respective posts".**

The selected candidates shall produce the following documents in original to this office at the time of joining failing which the right to appointment shall be deemed to have been cancelled ab-initio without any further notice:-

- a). Date of Birth.
- b). State subject Certificate/Domicile Certificate.
- c). Marks certificates of class 10th and 12th.
- d). Degree Marks certificate.
- e). Degree certificate.


An affidavit duly signed by 1st class Magistrate to the effect that:-

1. I have understood the terms of SO-364 of 2020 dated 27.11.2020, and shall abide by the terms and conditions of the said SO.
2. I will adhere to the roster of duties to be issued by the administration.
3. I will not participate in any kind of strike/protest against the administration during my tenure in the college / hospital.
4. My appointment will get terminated automatically and I shall have no claim on the post as soon as the post is filled by the competent authority on permanent basis.
5. That I am not working in any other institution/hospital etc.
6. If the documents filed by me are found wrong / incorrect at any point of time, my appointment shall be terminated immediately and disciplinary action and legal proceedings shall be initiated against me.


The appointment of the candidates is subject to the following conditions:-

- a. The appointee shall report to the Principal, Govt. Medical College, Baramulla for joining within a period of 07 days from the date of this order, failing which he/she shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.
- b. The appointee shall give an undertaking in the shape of a duly signed by 1st class Magistrate to the effect that:-
 - I). He has not been appointed in any other Govt. /Semi-Govt. department and is not working there at present.
 - II). In case adverse report about his character and antecedents is received from the Inspector General of Police (CID), J & K, the

Candidate shall have no right to claim his/her appointment and his appointment as such, shall be deemed to have been cancelled ab-initio.



- c. Salary of the appointee shall not be drawn and disbursed to them unless the satisfactory report in respect of (b) above is received in his/her favour.
