The appointment of these candidates shall be subject to the following conditions:-

- a. The appointees shall report to the Principal, Govt. Medical college, Baramulla for Joining within a period of 21 days from the date of publication of this order, failing which they shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
- Each appointee shall give an undertaking in the shape of an affidavit duly signed by 1st class Magistrate
 to the effect that: -
 - I). He /She has not been appointed in any other Govt./Semi-Govt. department and is not working there at present
 - Verification/ genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities
 - d. Salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (c) above are received in their favour.
 - e. The appointment of these candidates shall be governed under Jammu & Kashmir Special recruitment Rules,2020 Kashmir Probationer(Condition of Service, pay and Allowance) and Fixation of tenure rules,2020 notified vide SO 192 of 2020 dated 17-06-2020.
 - f. The appointees shall be governed by the "New Pension Scheme" as notified Vide SRO-400 of 2009 dated 24-12-2009.
