Subject: Engagement of Senior Residents in various departments of Government Medical College Baramulla.

## (ORDER)

Whereas Government Medical College Baramulla had, invited applications for the post of senior residents in various departments vide advertisement NO 05 RA of 2023 dated 25-04-2023.

Whereas last date for filling up of the applications for the post of senior residents in various departments of GMC Baramulla was extended till 06-05-2023 vide notice NO: - GMC/BLA/Acad/2023/588-92 dated 02-05-2023.

Now, the following candidates who had applied for the post of Senior Resident in various departments of GMC Baramulla notified vide advertisement NO:05 RA of 2023 dated 25-04-2023, are provisionally engaged as Senior Residents on academic arrangement basis under SO-364 OF 2020 dated 27-11-2020 in the following departments mentioned against their names,, initially for a period of 01 Year (extendable) on the basis of work conduct and performance as reported by the concerned Head of the Departments:

The selections are made strictly as per the eligibility criteria notified vide SO- 285 dated 18-08-2021 and selection criteria notified vide Government order no. 282 JK (HME) of 2023 Dated 04-04-2023.

However, engagement of the selected doctor shall be subject to the following conditions.

- 1. That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 10 days from the date of issuance of this selection order.
- 2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
  - a. He/she is a non- PSC candidate and in case of PSC candidate he/she shall submit NOC from the competent authority and proper relieving order from the parent department within a period of 15 days from the publication of this order, failing which his candidature will be cancelled.
  - b. He/she will complete his/her sanctioned tenure and will provide 01-month prior notice before resignation from the post.
- 3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
- 4. Salary will be disbursed only after the proper CID Verification of the candidates.
- 5. That all the documents submitted by the candidates are Genuine and in case any of the certificates fond forged, candidature of the candidate will be cancelled at any stage of recruitment process or service tenure without any prior notice.
