

The selections so made are strictly as per the eligibility criteria notified vide SO- 285 dated 18-08-2021 and selection criteria notified vide Government order no. 282 JK (HME) of 2023 Dated 04-04-2023.

However, engagement of the selected doctor shall be subject to the following conditions.

1. That the doctor shall submit his/her joining report in the office of Principal GMC Baramulla within 07 days from the date of issuance of this selection order.
2. That he/she shall submit an affidavit duly attested by first class magistrate to the effect that:
 - a. He/she is a non- PSC candidate and in case of PSC candidate he/she shall submit NOC from the competent authority and proper relieving order from the parent department, failing which he/she will not be able to join as resident doctor in this institution.
 - b. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - c. He/she will not indulge in private practice during the tenure. In case he is found, doing private practice his appointment shall be terminated without any notice.
 - d. He/she will complete his/her sanctioned tenure and will provide 01-month prior notice before resignation from the post.
 - e. That all the documents submitted by the candidates are Genuine and in case any of the certificates found forged, candidature of the candidate will be cancelled at any stage of recruitment process or service tenure without any prior notice.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
4. Salary will be disbursed only after the proper CID Verification of the candidates.

5. The selected candidates shall register themselves on HPR Portal of National Health Authority (under Ministry of Health and Family Welfare) and submit the hardcopy of the same as proof in the office of Registrar Academics GMC Baramulla.
