The Candidates shall report/join in the office of undersigned within 21 days from the date of issuance of this order and the candidate must produce the following original certificates at the time of joining.

1. Domicile Certificate.
2. DOB certificate.
3. Qualification Certificate.
4. Diploma Certificate/Degree certificate.
5. Category Certificate if any.
6. Other relevant Documents.

The appointment is subject to the following terms and conditions.

1. The candidate must be a Domicile of U.T of Jammu and Kashmir.
2. Canvassing in anyway will lead to disqualification of the concerned candidate.
3. The selected candidates shall have to submit an undertaking in the shape of affidavit duly attested by the 1<sup>st</sup> class magistrate to the effect that:-
  - i. The candidate should be a Domicile of J&K.
  - II. I will adhere to the roster of duties to be issued by the Administration.
  - III. If the documents filed by me are found wrong/incorrect at any point of time my appointment shall be cancelled.
  - IV. I will not participate in any kind of strike/ Protest against the Administration during my tenure in the college
  - V. I have not been appointed in any govt./ Semi Govt. Department and not working there at present
  - VI. Govt. Medical College, Baramulla deserves the right to terminate from the job at any time, if the performance of the selectee is not upto the expectation level as and if reported by the Concerned HOD. If the candidate wants to resign a notice period of 30 days is must.
  - VII. The posts are on contractual basis and temporary; do not confer any right for the selected candidates to the permanent absorption in the department.
4. In-service candidates are not eligible to apply.
5. Unmarried certificate in case of female candidates belonging to reserved category.
6. That if the candidate has taken loan for self-employment from District Industries Centre (DIC)/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the Domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the Financial Advisor & CAO, GMC Baramulla for his/her salary. Financial Advisor & CAO, GMC Baramulla shall obtain an affidavit from the concerned engagee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK (GAD) of 2023, dated 06.02.2023.
