Subject: Engagement of Senior Residents /Tutors/Registrars in the Department of Anatomy/General Surgery under SO-364 of 2020 dated 27-11-2020

Whereas; vide Government Order No. **383-JK (HME)** of **2024 Dated.20.06.2024** Criteria/policy Guidelines for Eligibility/Selection were framed by the Administrative Department, Health and Medical Education for eligibility/selection of the tenured positions of Senior Residents/Tutors/Registrars in all the Government Medical Colleges as per SO-364 of 2020 dated 27-11-2020.

Whereas; in accordance to the aforesaid guidelines this office vide Advertisement Notice issued under No. **06 RA of 2024 Dated. 21.09.2024** invited applications from the eligible candidates possessing requisite qualification for filling up of tenure posts of Senior Residents/Tutors/Registrars in the various disciplines of Government Medical College, Baramulla.

Whereas; in accordance with the guidelines the eligibility conditions were fixed as per Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022 issued by National Medical Commission.

Whereas; in terms of Government order NO. 383-JK (HME) Of 2024 Dated. 20.06.2024 there is no need to conduct written tests for selection purpose in the disciplines where the number of applications is less than or equal to the posts advertised.

Whereas; in response to the aforesaid Advertisement Notice, this office has received the applications from the candidates and, it was found that in the following Disciplines/Departments, the number of application forms received from eligible candidates available are less than or equal to the vacant positions:

Now, therefore, in light of the above stated position, the Annexure "'A" to this Notification is hereby notified for engagement/appointment of the senior residents /tutors/registrars against the available vacancies in the

aforementioned departments under SO-364 of 2020 dated 27-11-2020 initially for a period of 01 year (extendable upto a maximum of 03 years)

However, engagement/appointment of the candidates shall be tenured and provisional and shall be subject to the fulfilment of the following terms and conditions.

- 1. That the appointed resident doctors shall present themselves before the Documents Screening Committee along with the following documents in original (and 01 Xerox set of all the following relevant documents) by or before **18-10-2024**.
 - Date of Birth Certificate
 - MBBS Degree or equivalent degree
 - Marks Cards of all Professional Examinations
 - State MCI/NMC Registration Certificates.
 - Post-Graduate Degree Certificate.
 - Higher Qualification Certificate (if any)

2.In-Service /PSC Candidates shall submit the NOC for undergoing senior residency /tenure posting from the parent department in addition to the above documents/testimonials.

3. That the candidates shall submit an Affidavit duly attested by the first class judicial magistrate (format enclosed as Annexure B)

Note:- If any candidate(s) fails to present himself/herself before the Document Screening Committee within the stipulated time, candidature of such candidate(s) shall remain cancelled without any other prior notice.
