
Subject: - Selection of Senior Residents/Registrars in Government Medical College Baramulla.

Pursuant to recommendations of designated Selection committee which met on 31-08-2022, the following candidates who had come for the walk In-interviews against vide notification no:- GMC/BlA/Acad/2022/2232-38 dated 27-08-2022 are provisionally selected as Senior Residents / Registrars in the following Department under SO 364 of 2020 dated 27-11-2020, on academic arrangement basis initially for a period of **one (01) year** which may be extended on the basis of performance and Good conduct report by the concerned Head of Department up to a maximum of **three (03) years** for MD/MS candidates and **two (02) years** in case of diploma holders.

However, engagement of the selected doctor shall be subject to the following conditions.

1. That the doctors shall submit their joining report in the office of Principal GMC Baramulla within 07 days from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - a. He/she is non-PSC candidate and is not on the rolls of any other institution.
 - b. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - c. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
 - d. He/she shall not leave the department before the completion of his/her sanctioned tenure.
 - e. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
 - f. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of the tenure appointment at the time of their relieving.
4. No experience certificate will be issued if he/she leaves without completing his/her sanctioned tenure.
5. That they shall enter an agreement on the prescribed Form A.
