In terms of SO 364 of 2020 dated 27-11-2020, applications on a plain page are invited from eligible candidates along with duly filled information as per "Annexure A" enclosed to this notification for engagement against the vacant / likely to be vacant posts of Senior Residents on Academic Arrangement basis in the various department of Govt. Medical College Baramulla, initially for a period of 01 year, extendable up to maximum of 03 years (one year at a time) subject to good performance /work conduct as reported by the concerned Head of the Department.

The last date for submission of completed application forms in the office of Registrar Academics, GMC Baramulla is 15 September 2023 up to 4 PM.

3. Marks Cards of all Professional Examinations.
4. State/MCI/NMC Registration Certificate.
5. Post-Graduate Degree or Higher Qualification Certificate (D.M/M.Ch./Ph.D.).
6. State/MCI/NMC Registration Certificate for Post-Graduate Degree or Higher Qualification.
7. Distinction /National Scholarship /Honors /Medals /Academic Merit certificates.
8. Paper/Poster presentations of national/international conferences (if any)
9. NOC from Administrative department Health and Medical Education in case of in-service candidates.
10. Two recent passport size Photographs.
11. Other enclosures/certificates (if any) as mentioned in Annexure A shall also be enclosed.

Application Fee:

Application forms complete in all respects, should be accompanied with a non-refundable bank draft for Rs. 500/- (Rupees Five hundred only) pledged to Chief Accounts Officer, Govt. Medical College, Baramulla and payable at J&K Bank, TP Baramulla.

Selection Criteria:

The selection will be made in accordance with the Government order no. 282 JK (HME) of 2023 Dated 04-04-2023.

Other terms and Conditions:

- The candidates who have left the Senior Resident ship midway need not to apply.


The appointee shall also be entitled to house rent allowance (HRA), as applicable to in-service candidates carrying the minimum of pre-revised scale of the post subject to fulfillment of the conditions provided under the relevant rules in this regard.

- The appointments against the advertised posts shall and shall always be on academic arrangement basis only without conferment of any preferential right on the engagee for regular appointment against these posts, which shall be made strictly in accordance with the relevant recruitment rules.
- The services of an appointee under these rules can be terminated before the expiry of the tenure of appointment with one month's notice from either side or on payment of one month's salary in lieu of notice by the appointing authority.

Agreement:

The candidates shall have to execute/submit an affidavit at the time of submitting application form that:

- The candidate has not left the Senior Resident ship midway from any medical college/ institute.
- He/she will not leave the department before the completion of at least one year contract.
- That one-month salary will be withheld and shall be released after the successful completion of tenure. In case, the candidate leaves the assignment before one year, his/her one-month salary shall not be released. In case the candidate leaves the assignment after completion of one year he/she has to furnish one-month prior notice falling which one month salary shall not be released on his/her behalf.
- At the time of joining, he/she is not on the rolls of other medical colleges/institution of the country as required by NMC regulations.
- Incomplete applications in any respect or not appended with required documents shall be rejected without any notice.
- In case of any dispute, the decision of Chairperson of the Selection Committee shall be final.
