In continuation to the Provisional selection list notified by Govt. Medical College Baramulla vide Order No. 384-RA of 2025 dated 10-11-2025 and in pursuance to the Government order No. 383-JK (HME) of 2024 dated 20-06-2024, the following candidate is Engaged/Appointed as Senior Resident against Advertisement No. 09 RA of 2025 dated 19-09-2025, initially for a period of 01 year, extendable on the basis of satisfactory work conduct and performance of the candidate upto a maximum of 03 years.

However, Engagement/Appointment of the aforementioned doctor/s shall be subject to the following Terms and Conditions.

1. That the **doctor/s shall submit joining report** in the office of Principal GMC Baramulla within a period of **21 days** from the date of issuance of Appointment/Engagement order.
2. That the doctor/s shall produce all the relevant documents (as sought by the institution at the time of advertisement) in original along with 01 Xerox set in the office of Registrar Academics GMC Baramulla at the time of joining this institution.
3. Engagement of PSC-Confirmed / In-service candidate/s (if any) shall be subject to the submission of NOC and Relieving from the parent Department at the time of joining this institution.
4. That the **selectees shall submit original copy of affidavit** (as submitted earlier at the time of filling of application for) in the office of registrar office at the time of joining of this institution.
5. That the said doctor/s shall not leave the department before the completion of sanctioned tenure and will provide 01-month prior notice before resignation from the post.
6. First month's salary of the candidate/s shall remain in deposit with the accounts Department/Section as security and shall be paid on successful completion of tenure/s at the time of relieving. However, upon mid-way resignation by doctor/s without providing 01-month prior notice, the security

deposit of such resident doctor/s shall be confiscated and the resident doctor/s shall have no claim on the same.

7. No Experience Certificate shall be issued in favour of the resident doctor who resign mid-way without completion of the sanctioned tenure in this institution.
8. The selected candidate/s shall register themselves on HPR Portal of National Health Authority (under Ministry of Health and Family Welfare) / MedLeaPR Portal and JK-Sehat Portal.

1. That the certificates provided by me are genuine to the best of my knowledge, in case any of the certificate found forged or if I am found ineligible for the post by any means, my candidature will be terminated/cancelled without any prior notice at any stage of engagement and necessary actions as per the rules will be initiated against me including the recovery of salary (if served for any tenure period).
2. That I will be engaged initially for a period of 01 year, extendable (subject to work conduct and performance) upto a maximum of 03 years and upon completion of the maximum time period I shall not claim for further extension of tenure in this institution.
3. That if selected I will not leave the department midway before the completion of my sanctioned tenure.
4. That if selected I will not claim for any experience certificate before the completion of the estimated tenure.
5. That , I agree to the fact that if selected my first months' salary will be kept as security deposit with the accounts department and shall be released after the completion of the tenure at the time of my relieving and I shall have no claim for disbursement of security deposit in case of midway resignation and not providing of 01 month prior resignation notice.
6. That I understand the fact that if provisionally selected, my engagement and joining the institution shall be subject to the submission of CID Verification from the relevant department and in case of adverse report from CID or if I leave/resign before the receipt of CID verification, I shall have no claim for experience and salary for the served time period
7. That if selected I will follow the rules and regulations of the institution and will not indulge in private practice during my tenure stay in this intuition. In case of violation of such rules my services can be terminated and further action as per rules may be initiated against me.
8. That I am a non- PSC candidate and not on rolls of any other institution.

OR

That I am PSC-confirmed/in-service candidate and shall also submit NOC from the parent department for undergoing senior residency/tutorship/registrarship and relieving from the parent department at the time of joining this institution failing which my candidature / appointment may be terminated at any time of recruitment process/tenure in the institution without any further notice.

9. In case of fresh candidates: - that I have not done Registrarship /Senior Residency / Tutor / Demonstrator earlier within or outside UT of J&K

OR

In case of experienced candidates: - I am an experienced candidate and have already done Registrarship /Senior Residency/tutor /demonstrator-ship for a period of _ in the institution_____ and I understand the fact that the fresher candidates shall be given preference and if appointed I will be serving only for the remaining period so as to complete 03 years of senior residency in total. In case I have already done senior residency for a period of 03 years or more, I will be engaged/ appointed only if no fresher candidate gets available.
