However, Engagement/Appointment of the aforementioned doctor/s shall be subject to the following Terms and Conditions.


1. That the doctor/s shall submit joining report in the office of Principal GMC Baramulla within a period of 21 days from the date of issuance of Appointment/Engagement order.

4. That the said doctor/s shall not leave the department before the completion of their sanctioned tenure and will provide 01-month prior notice before resignation from the post.
5. First month's salary of the candidate/s shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of tenure in this institution at the time of relieving.
