Applications through online mode are invited from eligible candidates **not having done junior residency/House Job earlier** (for a period of 01 year or more in the UT of Jammu and Kashmir), for the **vacant / likely to be vacant** posts of Junior Residents in various departments/sections of Govt. Medical College Baramulla, initially for a period of **06 months extendable up-to a maximum of 01 year** on the basis of work conduct/performance as reported by the concerned Head of the Department.

Mode of selection: -

Selection of the candidates shall be based on the merit of the candidates in the Screening Test/Written Examination. However, the date of Written Examination/ Screening Test shall be notified separately on the official website of Govt. Medical College Baramulla.
