Subject: -Engagement/Appointment of Senior Residents/Registrars in the Department of Physiology GMC Baramulla.

Consequent upon the recommendations of the Designated Selection Committee and keeping in view the un-availability of fresh candidates (Not having done senior residency earlier for a period of 02 years or more), the following candidates are hereby provisionally Engaged/Appointed as Senior Residents in the department of Physiology GMC Baramulla in terms of SO 364 of 2020 dated 27-11-2020 on academic arrangement basis, initially for a period of 06 months till the posts are readvertised and some eligible Fresh candidate (not having done senior residency earlier for a period of 02 years or more) gets available for the post of senior resident in the said department. However in case of un-availability of the fresh PG candidates for the post after 06 months at the time of the re-advertisement, the extension in tenure appointment of the said doctors shall be subject to the approval from the competent authority/Head of the institution.

However, engagement of the said doctors shall be subject to the following Terms and Conditions.

1. That the doctors shall submit their joining report in the office of Principal GMC Baramulla within a period of 07 days from the date of issuance of Appointment/Engagement order.
2. That they shall apply for the verification of character and antecedents through online Employee Verifications System (EVS), and their Salary will be disbursed only after the proper CID Verification.
3. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - a. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - b. He/she will not indulge in private practice during the tenure. In case he/she is found, doing private practice his appointment shall be terminated without any notice.

c. That he/she is a Non- PSC candidate and not on the rolls of any other institution, in case of PSC confirmed candidate he/she will submit the relieving order from the parent department within the stipulated time.

d. He/she will complete his/her sanctioned tenure and will provide 01-month prior notice before resignation from the post.

4. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.

5. The candidates shall register themselves on HPR Portal of National Health Authority (under Ministry of Health and Family Welfare) and submit the hardcopy of the same as proof in the office of Registrar Academics GMC Baramulla.
