**Notification**

Whereas, the Government Medical College, Baramulla, invited online applications for the post of Junior Resident in various departments of GMC Baramulla vide Advertisement No. 07 RA of 2024 dated 06-12-2024.


Whereas in order to give opportunity to the fresh qualified MBBS candidates to work as junior resident, preference was to be given to the fresh candidates not having done junior residency earlier for a period of 01 year or more (the same stands mentioned in the advertisement notification No. 07 RA of 2024)

Whereas the experienced candidates were not clearly debarred from appearing in the examination and were to be taken only if fresh, candidates are not available for the said post against the said advertisement.

Whereas Government Medical College Baramulla, conducted the OMR Based Objective type Screening Examination on 23-12-2024.

Whereas a total of **04 candidates** who had earlier done junior residency for 01 year or more fall under the consideration zone of the merit list.

Now in view of the above, the 04 candidates in **Annexure A** are provisionally selected as junior residents against the available vacant posts of senior residents till the said post of senior residents are readvertised and some eligible PG candidate gets available in the department.
