 - b. He/she will complete his/her sanctioned tenure and will provide 01-month prior notice before resignation from the post.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
4. Salary will be disbursed only after the proper CID Verification of the candidates.
5. That all the documents submitted by the candidates are Genuine and in case any of the certificates found forged, candidature of the candidate will be cancelled at any stage of recruitment process or service tenure without any prior notice.
