**Application Fee:-**

Candidates are required to pay an amount of Rs.500/- as Form Fee through online mode by or before the cutoff date 25-06-2025.

**Mode of selection:-**

Selection of the candidates shall be made on the basis of the performance in the MCQ based written test. **(Strictly as per the criteria specified under Government Order No 383 — JK (HME) of 2024 dated 20-06-2024).** However the dates and other details of written examination shall be communicated separately in due course of time on the official website of Government Medical College Baramulla.

**Terms and Conditions:**

- 1. Fresh candidates not having done Senior Residency earlier (for a period of 03 years or more) shall be given preference. Application forms of the experienced candidates (having completed 03 years of senior residency/Registrar-ship) will be provisionally accepted, however their selection/appointment will be subject to the non-availability of fresher candidates.**
2. The Eligibility /Candidature of In-Service candidates shall be subject to fulfillment of all the pre-requisites, in accordance with the relevant rules, as envisaged in the J&K Civil Service Rules 1979 and providing of NOC from the parent department as envisaged in the circular No. 03- HME of 2019 dated 27-05-2019.
3. Pursuant to the Government Order No. 383-JK (HME) OF 2024 DATED 20-06-2024, the eligibility criteria and the upper age limit shall be strictly as per the Teachers Eligibility Qualifications in Medical Institutions Regulations.
4. Mere submission of the Documents/Certificates shall not be considered as final, candidature of any candidate is provisional and is subject to cancellation, Ab-initio, if found ineligible by any means at any stage of recruitment process / selection by the designated committee for the purpose/competent authority.
- 5. There shall be a waiting list, which shall remain in force for a period of 03 months from the date of issue of the selection list.**
