However, Engagement/Appointment of the aforementioned doctor/s shall be subject to the following Terms and Conditions.


1. That the doctor/s shall submit joining report in the office of Principal GMC Baramulla within a period of 21 days from the date of issuance of Appointment/Engagement order.
2. Engagement/Appointment of the doctor/s shall be subject to CID verification. The candidates is/are directed to apply for the same from the office of Administrative Officer GMC Baramulla immediately after the publication of this order.
3. The Selected/Appointed doctor/s shall submit the Additional qualification permanent registration certificate (issued by the JK-Medical Council) within a period of 2 months from the publication of this notification.
4. That the doctor/doctors shall submit the affidavit from 1st class judicial magistrate (as prescribed under Annexure A) at the time of joining this institution.
5. That the said doctor/s shall not leave the department before the completion of their sanctioned tenure and will provide 01-month prior notice before resignation from the post.
6. First month's salary of the candidate/s shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of tenure in this institution at the time of relieving.
