 That the doctor/s shall submit joining report in the office of Principal GMC Baramulla within a period of 21 days from the date of issuance of Appointment/Engagement order.

 That the doctor/s shall produce all the relevant documents (as sought by the institution at the time of advertisement) in original along with 01 Xerox set in the office of Registrar Academics GMC Baramulla at the time of joining this institution.

 Engagement of PSC-Confirmed / In-service candidate/s (if any) shall be subject to the submission of NOC and Relieving from the parent Department at the time of joining this institution.

 That the selectees shall submit affidavit duly attested by 1st class judicial magistrate at the time of joining (format attached under Annexure A)

5. That the said doctor/s shall not leave the department before the completion of sanctioned tenure and will provide 01-month prior notice before resignation from the post.
