The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

a. Bidders are informed to upload the details of the (make and model) quoted against each item. Non-compliance may result in disqualification of the bidder

b. Competent authority can call for samples at any time during the bid validity period. Noncompliance may result in disqualification of the bidder from the bid.

c. We require 05 pairs of Batting Pads and 02 Pairs of Wicket Keeping Pads in stead of 07 Pairs of Sports Thigh Pads as required items are not properly listed on Gem portal. Bidders are informed to quote the rates accordingly.

d. This bid is completely restricted for the bidders of UT of J&K only.
